MESSAGES

Message from the Chairman

Paul Robertson took over as our new Dean on September 1 of this year. He received his DDS from the University of Texas in Houston, his certificate in Periodontics from the University of Alabama in Birmingham and his MS in Experimental Pathology from the same institution. His past academic appointments include Chairman of the Department of Periodontology at the University of Connecticut School of Dental Medicine, Chairman of the Department of Stomatology at the University of California, San Francisco and Dean of the Faculty of Dentistry and Coordinator of Health Sciences at the University of British Columbia. Dean Robertson joined us at a recent departmental faculty meeting to share his thoughts about our Dental School and his vision for the future. He outlined his five major goals for the next several years: 1) Improve relations with the community -- this includes alumni, the upper campus administration, and the State Board of Dental Examiners. 2) Establish financial stability for the Dental School. As many of you know, the State of Washington is predicting substantial budget deficits for this fiscal year and the several to follow. State budget deficits translate into University budget cuts. While uncertain at this time, it is likely that the dental school faces a 1-2% budget cut this year and perhaps a similar reduction in each of the next several years. As you might assume, Dental School budget cuts translate into Departmental budget cuts. 3) Improve the intramural practice situation for faculty. 4) Gain full accreditation for the University of Washington School of Dentistry at its Accreditation Site Visit in 1995. 5) Improve the predoctoral clinical program.

I believe the Dean is quite committed to graduate dental education, but not at the expense of the predoctoral program.

As has been the case for the last number of years, we received an extraordinarily large and well-qualified group of applications for our graduate program. Nine of our faculty reviewed the applications and selected sixteen to come to Seattle for interviews. Those interviews were held in November and the final class of six was selected immediately afterwards. The six members of the class of 1995 are Drs. Hwe-Yae Chong, Singapore '84; Karen Hesse, Alberta '92; Doug Knight, UW '90; Anna Law, Tufts '93; Paul Nelson, UW '92 (and son of Jim Nelson, UW Orthodontic Class of '66) and Ken Norwick, UW '93 (and son of Ken Norwick, UW Orthodontic Class of '69). They are a wonderful group of future alumni who we look forward to educating during the next couple of years.

I am pleased to report that due to the generosity of one of our alumni, we have established an Orthodontic Graduate Student Loan Fund, administered by the Dental School. These funds will be available to orthodontic graduate students who need additional resources for either tuition or personal living expenses during the program. Dental education is extraordinarily expensive these days and we hope that this will help to ease the burden for some students. Repayment at a moderate interest rate does not begin until after the program has been completed and can take up to eight years. We will be pleased to accept additional contributions to this loan fund.

I would like to express my appreciation to those of you who have contributed directly to the Department or to the Alumni Association for the benefit of the Department. These contributions are critical to maintaining the excellence of the Department and are used primarily to support our research program. We are grateful for your support in this time of declining resources from the State.

I look forward to seeing each of you at the Alumni Reunion this coming July and to have the opportunity to report to you more directly about the activities of our Department.

Message from the President

This past year your Board evaluated the overall "operation" of the Alumni Association. We formed a committee to examine the general progress and business efficiency of our organization. Our goal is to operate the Association within an income stream drawn entirely from alumni dues so that contributions from pledges and other creative fundraising techniques would be directed toward department support, such as research for students and equipment. We then set guidelines for more participation by the Board and less utilization of our Executive Director. As a result of these recommendations there was a change in our Executive Director position and several changes in our budget for 1993-1994. Since 1990, we have progressively increased the Alumni dues in an attempt to reach a more realistic operating budget. After much analysis and "soul searching," we found that the current dues must be set at \$130 per year. You have already received your new dues statement and I respectfully request all alumni and "friends of alumni" to comply to help with our overhead needs. While we have been presented with many creative ideas over the past two years in terms of individual estate planning, we decided to get back to "basics" in our fundraising techniques. We feel our continuing 5-year pledge via the phonethon and letters to all alumni and friends is still the best technique to contribute to our endowment fund. We are asking for a pledge of \$2500 paid over 5 years. Always keep in mind the "contribution in lieu of" idea of making your donation by having another professional contribute in your name to the Alumni Association for treatment provided. I encourage all of you to make contribution pledges as well as pay your annual dues, anticipating that we can report in July at the Reunion that our \$500,000 goal has been accomplished! I look forward to seeing you this summer. Have a GOOD year!

PASSINGS

DR. PAUL LEWIS

Paul Donovan Lewis passed away peacefully on December 6, 1992. Born in Bucoda, WA on June 4, 1896, he spent most of his youth in Bellingham. He attended the North Pacific College of Dentistry and Pharmacy (now the Dental School at the University of Oregon). He practiced dentistry for a few years in Monroe, WA, at which time he was a member of the Ferrier Gold Foil Study Club. During 1923, Paul attended the Dewey School of Orthodontics in New York and subsequently became an assistant with Dr. Dewey. It was in New York that he met Virginia Thrall, who was to become his wife. Paul returned to Seattle to establish his orthodontic practice. He and Virginia were married in 1925 in Everett and resided in Seattle on Queen Anne Hill and later in the Magnolia district. Paul was a frequent instructor in Tweed Foundation courses in orthodontics at Tucson, AZ, during the 1930's, 1940's and 1950's. In 1948, Paul and the four other members of his study club became founding faculty members of the Department of Orthodontics at the University of Washington, where he taught and served as a mentor for students until 1978 - and intermittently thereafter until 1985. Paul enjoyed golf with his pals during his more than 40 years of membership at Seattle's Broadmoor Golf Club. His dental fraternity affiliation was Psi Omega. He was a fellow in the American College of Dentists. In 1986, Paul received the prestigious Ketcham Award at the annual meeting of the American Association of Orthodontists. He received numerous other awards and honors, most recently a recognition by the University of Washington

Department of Orthodontics on the event of his 95th birthday in 1991. He was a pioneer in the field of orthodontics and the inventor of the Lewis bracket. Several of his research publications are still cited in orthodontic literature today. In the course of his orthodontic practice over the years, Paul had a number of associates and partners, most notably Dr. Robert Kemp, with whom he had a partnership for 33 years until his retirement in 1986 at the age of 90. Dr. Lewis is survived by his loving son, Dr. Paul Lewis, Jr. (and wife Margaret); four grandchildren and a great grandson. Memorials are suggested to the Orthodontic Memorial Fund, c/o Department of Orthodontics, University of Washington.

DR. ROBERT MENDEL DR. TODD MENDEL

Dr. Robert Mendel and his son, Dr. Todd Mendel died September 7, 1992, as a result of a seaplane accident on Vancouver Island, B.C. Robert Mendel graduated from the University of Washington Orthodontics School in 1962 and maintained practices in Mercer Island and Seattle. He held memberships in many associations including Tau Kappa Epsilon Honorary Dental Fraternity, American Orthodontic Association, and the Rotary Club. Dr. Todd Marshall Mendel was enrolled in the University of Washington Orthodontics program at the time of his death. He too was a member of many organizations including Omicron Kappa Upsilon Dental Honorary Fraternity and Tau Kappa Omega Honor Society.

Memorial services were held on September 14, 1992. In lieu of flowers, the family had requested memorials to be made to the UW Dept. of Orthodontics or the University of the Pacific Dental School.

DR. WILLIAM S. TAKANO

Bill died November 7, 1992 after a short illness. He was born in Auburn, Washington in 1924, spent his early years in the Seattle area, and his college years in the East. Bill received his D.D.S. (cum laude) from Marquette University in 1948, and his M.S.D. in Orthodontics from the University of Washington in 1950 in the very first class. He soon opened his practice in Seattle and continued until his death, having been joined in the office by his brother, Jim, in 1961. During this time he arranged to leave the practice to someone else while he spent two years in the Navy Dental Corps in San Diego. Bill taught at the University of Washington for 22 years, and was active in the P.C.S.O., the Angle Society, the Tweed Society, and the Crystal Study Club. He was an avid outdoorsman and excelled in fly-fishing, salmon mooching, duck hunting, and especially skiing. He was always a true and loyal friend and will be sorely missed.
