Dr. Peter Shapiro New Department Chairman as of July 1984

The search is over and Dean Karl-Ake Omnell has announced that **Peter Shapiro** will succeed Don Joondeph as chairman of the orthodontic department. The announcement culminates an extensive international review of more than 20 potential candidates for this prestigious position.

Dr. Shapiro follows a tradition of excellent leadership that the orthodontic department has enjoyed for the past 35 years. This tradition began with **Al Moore** in 1948, was passed to **Dick Riedel** in 1965, to **Don Joondeph** in 1975 and now to Peter Shapiro.

Peter is no stranger around the orthodontic department having received his orthodontic training and completed his master's degree requirements in 1973 here at the University of Washington. He previously earned his undergraduate degree in English literature at Brown University in 1966 and was awarded his dental degree by Howard University in 1970.

After completing the orthodontic residency in 1973, Peter was awarded a postdoctoral teaching fellowship which he held until 1977. During that time, Peter strengthened his teaching methods and developed an interest in experimental primate research. After the fellowship Peter was appointed as Assistant Professor in the orthodontic department and was rapidly promoted to Associate Professor on the basis of his research productivity. Peter has published 4 book chapters and over 20 scientific articles during his 10 year career as a faculty member at the University of Washington.

Peter is a sought after speaker at orthodontic meetings. He has given more than 30 presentations and continuing education courses around the United States as well as in Mexico, Canada, South America and Europe.

Peter is also well respected within the dental school and in the Seattle orthodontic community. He has served as chairman of the powerful Curriculum Committee of the dental school for the past two years. He is also a member of the Northwest component of the Edward H. Angle Society and has been scientific program chairman for both the National Angle Society meeting and the Pacific Coast Society of Orthodontists' annual meeting.

Peter's wife, **Gail**, is a respected clinician and researcher in her own medical specialty. As a pediatric allergist, she and Peter have collaborated recently on research projects that are attempting to evaluate the effects of allergic rhinitis and mouth-breathing on facial growth and development. Peter and Gail have two lovely children, Evan and Jessica.

Based upon his impressive credentials, it appears that the chairmanship of the orthodontic department is in good hands with Peter Shapiro. Under Peter's leadership, the department is looking forward to continuing the fine tradition that has been set by the orthodontic alumni that have graduated from the University of Washington. □

Ortho Clinic Undergoing Changes

We are currently reorganizing the graduate and undergraduate orthodontic clinics in all phases of operation. The Dental School is moving toward a requirement for all clinics to be fiscally self-sufficient. The streamlining that will take place in our clinic will also have added benefits for student education and delivery of care to patients.

During the Fall Quarter we are hiring four new employees. There will be a full-time

supervisor to work along with the current program assistant. In addition, there will be three part-time (70%) chairside assistants. These individuals will work with both undergraduates and graduate students in orthodontics and their duties will include essentially all such tasks as they are currently performed in our own private practices. This will allow us to run a "tighter ship" and teach our students how to practice orthodontics with assistants. As an offshoot, patient care will improve along with the number of patients treated by the clinic.

If you haven't visited the clinic recently, feel free to drop in the next time you are in town. There have been some physical changes made during the last few years as well. The clinic is now all on one floor and the chairs are divided between two rooms with the dispensary located in the middle. Each room has its own separate consultation unit for treatment discussions and other consultations with patients, parents and outside consultants. During the next academic year we hope to also add audiovisual aids for patient and parent education utilizing videocassettes. Clinic

forms are under revision now, also, to make them conform more closely to the private practice setting. We are all very excited about these changes and would certainly welcome any suggestions from the alumni for changes that we might consider in the clinic operation. This can run the gamut from how to train an assistant to a specific office form. We are always open to suggestion. Please feel free to send me your ideas. **Marc Joondeph** □

Distinguished Visitors in Department

Visiting Professor **Dr. Michinobu Irie** joins the Department for six weeks of research and collaboration. Dr. Irie is on leave from Nakasaki University in Japan where he is chairman of the department. The focus of his visit is to learn our techniques and experience in the treatment of Class III malocclusion. Retention and stability of cases treated with or without surgery is of particular interest to the Japanese, the incidence of the malocclusion being far greater than in the United States population.

For the next year we are pleased to have **Dr. Jon Artun** with us from the University of Oslo. He is a research scholar on a one year government sponsored leave which we hope will be productive for him and our faculty. Dr. Artun plans to participate in our teaching program to broaden his skills and experience but also wishes to continue his research. The iatrogenic effects of various bonded retainers and bonding materials is of particular interest as is the periodontal status of roots orthodontically positioned in close proximity. Dr. Artun brings his wife and three children, all of whom are readily adapting to Northwest living.

We welcome these visiting scholars and look forward to a productive working relationship. □

ton State Society of Orthodontists and was also promoted to Professor of Orthodontics. His publications this year include two articles that have been published and four more in press.

Bill McNeill has found the past year to be extremely busy serving as president of the PCSO and of the University of Washington Orthodontic Alumni Association. Relief is in sight, as his term as PCSO president comes to an end at the annual meeting which will be held in Hawaii October 27 through 31.

Dave Turpin continues to provide excellent direction and leadership to the Pacific Coast Society Journal and, with Peter Shapiro, will be acting as co-chairman of the scientific program for the biennial meeting of the Edward H. Angle Society to be held in Vancouver B.C. August 1985.

This year, **Stan Hall** was accepted into membership in the American Society of Bone and Mineral Research and was listed in Who's Who in American Frontier Science 1984. He served as president of the Sigma Sigma chapter of OKU for 1983-84 and presided over the June banquet honoring the 1984 dental school graduates. Last March he, **Jay Decker** and **Leena Koskinen-Moffett** made presentations at the IADR meeting in Dallas, Texas. In the last year Stan has published two scientific papers with four more awaiting publication.

Jay Decker has in addition to his scientific endeavors has assisted in the teaching of the annual course presented by the Department of Orthodontics on the biology of temporomandibular joint dysfunction presented by a multidisciplinary group including Jay, Ben Moffett and Leena Koskinen-Moffett. Jay presented a paper before last year's IADR meeting and has another paper accepted for publication in the American Journal of Anatomy.

Marc Joonedeph continues to provide superlative organization in orchestrating the curriculum for orientation and orthodontic technique. He will be presenting a round table discussion at the annual PCSO meeting to be held in Hawaii in October. He is presently outlining a new informed consent procedure to be used by patients in the Department of Orthodontics.

Richard A. Riedel, as always continues to provide excellent clinical instruction in gradu-

ate seminar and clinic and is now teaching half-time. He continues as ever to provide the sage advice as necessary to continually renew the sensation of humility amongst his peers.

Mike Fey has spent the past year introducing the new undergraduate curriculum in orthodontics which is designed to provide both didactic and clinical experiences for all undergraduate students. This has necessitated a reorganization of the course offered in prior years and expanded the clinical portion in the summer of 1984 to include all students in the junior year of dental school. In conjunction with this he, with the rest of the department, will now assist in managing an undergraduate clinic in minor tooth movement.

Ben Moffett has been very busy with greater focus placed on biologic diagnosis of temporomandibular joint dysfunctions. In addition to heading up the departmentally sponsored multidisciplinary TMJ courses, he spoke at the Orthodontic Education and Research Foundation in St. Louis, and with **Leena Koskinen-Moffett** presented papers at the IADR and Cleft Palate meetings. Leena and Ben are part of a team teaching a two day course on Diagnosis of TMJ Internal Derangements. We are looking forward to hearing Ben at next year's Alton Moore Lecture. We hope to see you all there.

Senior Research

As usual, the graduate students are busily exploring a wide variety of clinical and basic research areas in their quest for Master's Degrees. The results of their research activities will be presented at the annual Alton W. Moore Lectureship to be held on Friday, June 7, 1985 in Seattle. As you are aware, the Alumni Association provides the majority of the funding for these research projects, and we thank you for your continuing support. Listed below are the topics identified by the class of 1985:

Sara Devine: A qualitative assay for the resistance dental tissues to invasion.

Stephanie Kavanaugh: Maxillary segmental osteotomy: its effect on dentoalveolar support in the non growing patient.

Mark Kitamura: A cephalometric comparison of skeletal and dental changes associated with cervical headgear versus cervical headgear and maxillary anterior appliances.

Gary May: Extirpation, in vitro culturing, and reimplantation of cranial sutures in the young rabbit.

Trent Rencher: An analysis of variation in glenoid fossa position in untreated individuals with class I versus class II malocclusions.

Gina Trask: The effects of allergic rhinitis on the facial skeleton, dentition, head posture, and airway resistance.

Dennis Winn: Prenatal calvarial bone growth in *Macaca nemestrina*: a radiographic and histologic study. □
