REMEMBERING EMERY FRASER BY KENNETH KAHN (Class of 1950)

The last surviving member of the original clinical teaching faculty of our UW Orthodontic Department passed away in Seattle on February 7, 1995.

He was born in Waterville, WA in 1902 and graduated from Northwestern University School of Dentistry. After practicing for a short time in Spokane, WA, he moved to Seattle in 1929 to continue his practice of dentistry and orthodontics.

Dr. Fraser was a pioneer of sorts - one of a group of excellent and very active dentists in this area who changed very early to orthodontics exclusively. This was pioneering because there were few training programs available to Emery. He attended the Dewey School in New York. There he met Dr. Edward H. Angle, considered by most of us to be the "father of modern orthodontics" - and a generous and patient teacher.

Emery's greatest mentor, however, was Dr. Charles H. Tweed from Tucson, Arizona. He attracted Emery because of his reputation for solving difficult problems, albeit by extraction of teeth (not too popular at the time).

Emery was joined in his adoration of "Charlie" by others in this area, namely: Dr. Pete Bishop, Dr. Milt Fisher, Dr. Paul Lewis, Dr. Bill McGovern - and it was this group who planned the faculty agenda for the newly developing Graduate Program at the University of Washington. (Dr. Milt Fisher died before the program started in March, 1949.)

I was a member of the first class and remember Emery as an excellent clinician - but serious and demanding. On Tuesdays when he supervised, our gold (YES, ALL GOLD) appliances had to fit like inlays or be done over.

He was meticulous, and this must have characterized his entire life! I'll tell you, it certainly influenced us as students - and we soon learned that there was only one way to do things - his way, the right way!

We left his guidance feeling that we had done more for our patients than we had done for their teeth. I, for one, am grateful for this feeling that stayed with me all my years of practice.

He will be sorely missed.

Dr. Allan Van Ness (class of 1972) decided to undertake the formidable task of collecting these great memories and is preparing a booklet that will be made available to alumni in the near future. You may recall his letter asking you to send in your special Department memories. The response has been terrific. So much so that we want to include a few of the wonderful responses in this newsletter. "If it's white, better band it!" (Phillip Barer)

(After hearing one of us "hem, haw, and beat around the bush" about what to do in treating a case):
"Come on - they're in the waiting room!" (Ron Gallerano)

"We always like to accept people from Texas because they always go back. I don't know why..... I went there once!" (Ron Gallerano)

"Tie it in and see what happens." (Jim Garol)

"If there is a lower incisor present in the mouth it will probably rotate." (Paul Henderson)

I summoned Dick to my chair, in the Friday morning clinic, anxious to hear his opinion about space closure. Amongst my classmates, we had argued the merits of sliding mechanics versus closing loops. As I showed him my "straight" arch wire and coiled spring, which I wanted to use on my patient, I anxiously anticipated his reply. Dick looked in my patient's mouth, grunted at my arch wire and calmly declared, "I tried that once." With that, he smiled and walked away! (Mark Joondeph)

Riedel taught us (class of 68) how to bend a lingual arch. None of us could bend it as wide as Riedel's. We noticed that he had a huge thumb around which he bent the wire. So we took an impression (Jeltrate) of his thumb and made 11 models so everybody could bend the lingual arch with Riedel's thumb. (Roberto Justus)

After Jim Horn referred to one of Dr. Riedel's arch wires as a "wonder wire," Dr. R. said "Yah, you wonder how they work!" (Bob Julius)

If you first get the question right, the answer follows of itself." (Bob Julius)

Discussing anchorage: "We could have made a fortune if we had invented elastics that would pull only at one end!" (Ken Kahn)

I remember, on more than one occasion, asking Dr. Riedel a question on some aspect of mechanics. He would sit down and ask me : "What would you do doctor?" I would respond with a detailed 'how and why.' Dr. Riedel would stand up, nod his head (in apparent agreement), and walk away. As he shuffled off, his departing words were "YOU could try that, but I don't think I would" - and he'd be gone. (Ed Poremba)

"You had better treat that case before it treats itself!" (Steve Spurrier)

A frequent Riedel quote: "Knowledge does not make one a leader, but it should help one discover which leaders to follow." (Ed Supernaw)

Dick was always very protective of plaster casts, wanting to handle them with care to preserve the anatomy, etc. One day we prepared a "fall apart" set of models as part of a case presentation. As the models were passed from person to person, one of the students "accidentally" dropped the casts on the table. The casts shattered into pieces as planned - teeth were flying everywhere. Dick opened his eyes and said "*!%&#." When we all broke up laughing, he realized he had been "had" and started laughing too. He was a great instructor. (Dan Taylor)

Kenneth Norwick ('69) is now joined in practice by his son **Ken Norwick ('95)** and they are having a great time!




