# Message from the UWOAA President - Bruce Hawley

Greetings to all of our alumni and friends from the Officers and Board of Directors of the University of Washington Orthodontic Alumni Association! I am pleased to report that the state of our organization continues to be excellent, with fine leadership both individually and collectively from your Board. As we look forward to leading the Association into the millennium, it may be appropriate first to take a look back over the past year.

A definite highlight for us was the successful Clinical Update this past March in Ixtapa, Mexico. This meeting seemed to outdo all previous ones, with an outstanding scientific program presented by several of our faculty and alumni members. As was the case for the previous Update, Ixtapa is an ideal resort, and our attendees could hardly have wished for more in the way of sun, beach, cuisine, and a marvelous hotel setting in the Westin Brisas. As usual, the camaraderie and fellowship were terrific.

At our annual Moore Lectureship in June, the graduating seniors presented outstanding synopses of their research investigations on a variety of different topics, illustrating without doubt that our Department is in the forefront of orthodontic research and education. Vince Kokich, our featured speaker, discussed "ABO Standards and Adult Orthodontics: Are They Compatible?" This coming June 9 will mark the 20th annual Alton W. We are thrilled to announce that our keynote speaker will be none other than Al Moore, who will be giving us his perspectives on Orthodontics and our Department over the years. # Message from the Department Chairman - Greg King

Several exciting things will be happening in the Department in the coming months. On December 8<sup>th</sup> and 9<sup>th</sup>, Bjorn Zacchrisson will be here as the 1999 Kokich-Shapiro Lecturer. He will spend two full days interacting informally and exclusively with the graduate students. This format has always been one of the high points of the year for the orthodontic graduate students. In addition, this year, Professor Zachrisson will be offering a one-day course to the community of orthodontists on esthetics (December 10). Contact CDE if you are interested.

This year, the Moore Lecture and Thesis Day will be on June 9<sup>th</sup>. It will be a very special day for several reasons. The 1999 graduates will be the last class on the 8-quarter curriculum. Because of the switch to a 10 quarter curriculum in 2000, Thesis Day and the Moore Lecture can no longer take place in June but instead must move to the latter part of the Fall Quarter. We are trying to increase our chances for good weather and to avoid the holidays, so it looks like the best choice will be October. This timing should permit good presentations at Thesis Day with ample extra time available for the graduates to make finishing touches on their theses before the December deadline. This should also alleviate the "last minute rush" that we are certain everyone remembers from his or her student days.

This year will also be the 20<sup>th</sup> anniversary of the Moore Lecture. Al Moore has consented to give this very special lecture. Most of us know that Al is fond of great stories about orthodontics, especially in the early days. So I urge you not to miss this opportunity to learn a little more about your heritage as a UW orthodontist. We hope to make this a very special day with Al, Peter Shapiro, and Don Joondeph, so stay tuned.

A few months ago, the UW School of Dentistry was notified by NIH that it would be one of three dental schools nationwide to receive a comprehensive center for oral health research. These represent \$7 million dollars of federal funding for research over 5 years. The most exciting part of this for us is the UW Center theme—"The basis of oral and craniofacial health and susceptibility to disease: a focus on the child as a key to lifelong oral health." I'm sure that I do not have to tell you that this theme has particular significance for us as orthodontists. In addition to funding research projects proposed by departmental faculty (e.g., distraction osteogenesis, suture biology), we also hope to develop other new areas of research activity under the center theme (e.g., quality of life assessments, increasing access to orthodontic treatment). The importance of this Center for the School and Department in the coming decade cannot be over-emphasized. It will define us as the leader in children's oral health research worldwide.

Another exciting recent development involves the Invisilign appliance. You have probably heard about this new approach to using a series of computer generated positioners to treat minor malocclusions. We have been funded by Align Technologies to conduct a clinical trial designed to examine issues related to material consistency and rate of reactivation. This will give us the opportunity to develop expertise with this approach to treatment, as well as to participate directly in its development.

John van der Pyl ('72) writes to let us know that he's retired and staying put - why not when it's in beautiful Guam! Happy Retirement, John!



# Faculty Profile



Dr. Dave Turpin ('66)

Each year, we use our newsletter to profile individual faculty members at the UW Orthodontic Department. This year, we are happy to feature a member who not only shares his expertise with our graduate students, but with all AJO-DO subscribers as their upcoming Editor-in-Chief: Dr. Dave Turpin.

Dave's professional career spans over 30 years at the UW and 33 years in private practice. He has simultaneously maintained great interest in the editorial process and has put this interest to good work, serving as Editor of the PCSO Bulletin (10 years) and the Angle Orthodontist (11

years). Now Dave will continue his editorial role in a larger and prestigious format with the American Journal of Orthodontics and Dentofacial Orthopedics. In early December 1999, the AJO-DO editorial office will begin operations at its new location in the UW Department of Orthodontics. There, Dave will serve as Editor-Designate along with assistant, Chris Burke, until current Editor-in-Chief, Dr. Tom Graber, completes his final issue in May, 2000. Dave's first turn as Editor-in-Chief will begin with the AJO issue in June, 2000.

Dave's history of successful publication work included innovative thinking with the PCSO Bulletin during his term as Editor. "To improve interviewing and writing skills I established an annual workshop for the magazine's personnel, drawing upon the American Dental Association as well as educational institutions in the area for additional expertise. This effort resulted in a complete redesign of the PCSO Bulletin in 1985, and an increase in both size and content. As a result, we won the Golden Scroll Award from the International College of Dentists for the most improved overall design of a publication that year. "

As an Affiliate Professor at the UW, Dave truly enjoys working with the students. He has witnessed phenomenal changes as technology impacts the profession. "During the past two years, the technological abilities of the students have increased dramatically. Students are now accustomed to using computers since junior high, and it's exciting being associated with them."

Given Dave's interest in using technology, it comes as no surprise that he intends to put that interest to good work at the AJO-DO. One of his first jobs during the year 2000 is to bring the journal fully on-line and available to current AAO members at no extra cost. It is anticipated that with the electronic publication of all manuscripts, and a streamlining of production schedules, the time it takes to publish research findings will be shortened. "The increased use of new technology makes this an exciting time to be involved with others in making it work to simplify.not complicate our lives. The opportunity to read a scientific paper interactively is something else most clinicians have not yet experienced."

Along with associates Heather Woloshyn ('93) and Jacklyn Kurth ('99), he uses video imaging as a standard tool to help patients make decisions regarding their orthodontic treatment.
