Message from the UWOAA President Tim Shields

Happy Holidays from Seattle. It's looking like an early ski season in the Cascades – but perhaps not quite yet for the senior class as they are busy finishing up cases and preparing for graduation. The past year has been a busy one for your Alumni Board as well. We hosted several meetings, restructured our board, and are planning for the future.

We celebrated the 23rd Alton Moore Lectureship on November 22nd. Once again the student presenters did an outstanding job on both their projects and their presentations. I expected as much after meeting with the seniors and several alumni board members last September for an informal luncheon. We certainly can all be proud of these new University of Washington orthodontists. Dr. Anthony Gianelly, this year's Alton Moore Lecturer and past Chairman of the Boston University Orthodontic Department, had many kind words for Al Moore and our distinguished program. The 2004 Ketchum Award winner entitled his talk, "Timing of Treatment: An Evidence Based Assessment," and it was both informative and timely. To be sure, a lively question and answer period ensued.

Jim Clark and Peg Evered were recognized at the lecture for their many years of service to the Department with gifts from the Alumni Association. Both Jim and Peg have announced their retirement at the end of the school year, although Jim will be available to the department as a consultant.

Last spring many of us enjoyed the Alumni Update in sunny Playa del Carmen near Cancun, Mexico. An outstanding program was presented by the faculty, and as always, the highlight was the fellowship amongst the Alumni. This was my fourth Update, and each time, I leave a little wiser and a lot richer for the new friends I have gained.

The board has focused on strategic planning in recent months. One issue has been the length of service required to move through the executive positions. Given today's demographics of two income families and more women in orthodontics, we sought to make the time commitment less burdensome. For example, our immediate past president Bruce Hawley has two years of a 16 year commitment remaining as an officer –not including prior time as a director! To cut to the chase, we changed the bylaws such that Bruce's participation now would be down to nine years – three as the Secretary/Treasurer, three as the President, and three as the Immediate-Past President. The directors' commitment has been pared down as well, going from eight years to six. We will now be on a three year election cycle, electing one-half the directors and the officers every three years. Our biennial meeting cycle of Alumni Reunions in Seattle and the Updates at tropical destinations will be scheduled on a more flexible basis. Our goal to make the meetings more convenient, and well, just a little more special.

Tentatively, the Alumni Reunion will coincide with the AAO annual meeting in 2007 in Seattle- during Don Joondeph's Presidency of the AAO. The format will be social and complementary to the AAO meeting. And be sure to look for our Alumni receptions at the annual AAO and PCSO meetings – the next one will be in Orlando!

We continue to provide direct support for the student research. The board approved a motion this fall to provide funding of up to \$15,200 to the Department to cover research as of yet unfunded by other grants. This continues to be our nuts and bolts function, while continuing to work funding both the Kokich-Shapiro Lectureship and the Moore-Reidel Endowed Chair. Both funds are well on the way toward full funding. Many thanks to you all, again, for your continued support of the Department through your generous contributions to the Alumni Association.

When I was in the B-Wing to meet with the seniors this past September, it was déjà vu all over again. *Really*. In the 22 years since I first stepped into the hallowed B-wing Clinic, the cinder blocks still look just as lovely and inviting. There have been a few minor projects and a few fresh coats of paint here and there, but let's face it: the facility simply doesn't reflect the excellence of our program. I have remodeled my own office three times since I began practice in 1983. If we are to continue to attract top faculty and students, the Board feels that a modern clinic is imperative. The exciting news is that there is movement a foot to remodel the entire Dental School. There have been preliminary sketches drawn, but the reality is that at this time no funding for any actual construction has yet been appropriated. Your board is actively exploring ways the Alumni Association can contribute to the project. The University of Michigan has a fantastic new clinic funded primarily through their alumni. Rest assured that the Alumni Board will be looking for ways to make the proposed remodel a reality. A possible scenario might unfold where the first state money that becomes available might come our way if we are prepared to match funds. You may recall that the Moore-Reidel Chair was born when \$250,000 of state money went looking for a home – we deftly matched the grant and the rest is history. The board and I are excited at this prospect to make a lasting contribution on behalf of the Orthodontic Program.

As I close, let me express my gratitude to Dr. Greg King, the faculty, and the Alumni Board for working hard to maintain the excellence of the U.W. Orthodontic Program. Also, thanks to the Board's right hand - Executive Director Joni Marts. Lastly, fantastic job everyone for your financial support of our alma mater!

Message from UW Department Chairman Greg King

If you graduated from the UW Postgraduate Program in Orthodontics since the mid seventy's, you might feel at home in our clinic today. This is the case because we have not had a major renovation since that time. We did some minor cosmetic things a few years ago with the conference room and converted the old photography room into a computer and imaging facility, but the rest is pretty much the same. This is even more surprising when you consider that all of our peer programs have done at least one major renovation during that period. What is even more surprising to me is how little this situation seems to bother our students, faculty and staff. We are still perceived as one of the premier orthodontics programs in the world by many and, by any of the objective measures that people in academics use to judge these things (e.g., grants, papers, leadership of the profession, teaching excellence), this perception may be correct. The level of delight, pride and productivity that I see in our students, faculty and staff far surpasses what you might expect from people working in a worn and outdated facility. We continue to compete successfully for the highest quality graduate students, and have managed to fill our vacant faculty positions with excellent young faculty members in both the clinical and research tracks, despite depressing trends around the country. Our greatest boosters seem also to be our greatest assets: the faculty, staff, students, and patients. Clearly, it is the people who make this program what it is, not the physical plant. Moreover, the people we are blessed with seem to be able to excel despite, rather than because of their physical surroundings.

I seem to be making quite a good case for leaving things the way they are because the evidence would suggest that a major clinic renovation might not be absolutely necessary for our success. We certainly could continue with minor cosmetic upgrades and probably still compete at the highest level for students, faculty and patients. However, I would express two strong emotions that make the opposite case. The most obvious one is pride. The Program is excellent and does deserve to be in a facility reflecting that excellence. The second is fear. I fear that complacency can erode success, especially in times of shortage. Orthodontic faculties are small and the competition for the good ones is becoming fierce. It

doesn't take the loss of very many faculty members to put a really big dent in a good small program. Likewise, the competition for the best graduate students is also fierce. Granted, there are lots of applicants every year, but we want the absolute best, and so does everyone else. I wonder sometimes what these young people think when they come here to interview after having been to one of our peer programs that has a nice new facility.

Next year the School of Dentistry will begin a major fund raising campaign. Each department has been asked to list some important goals that should be the focus for such a campaign. We have only one item on our list – renovation of the graduate orthodontics clinic. We have a one-item wish list primarily because we have been fortunate in ways that other departments in the School have not. We have the Moore Riedel Endowed Professorship and I expect that to become vested in 2004, allowing us the luxury of recruiting another faculty member. We have the Kokich-Shapiro Lectureship, the Alton Moore Lectureship and support for our student research. I cannot overemphasize how important those things are to us, and they are in place because of the generosity of our alumni. After much consideration, the Board of Directors of the UW Orthodontic Alumni Association has decided to also focus its fundraising efforts for the immediate future on this renovation project. I applaud this decision because it is time to do something. To me this decision demonstrates one other fabulous advantage that our department has over others in the school and many other orthodontics departments in the country—the excellent support of its alumni.



Contributions Update...

CONTRIBUTIONS UPDATE

Your continuous and generous contributions have been the foundation for Association support to the UW Orthodontic Department. Alumni have asked about how their contributions are received and credited by the Association. Here is a brief breakdown:

TYPES OF CONTRIBUTIONS

1. *Contributions to the UW Orthodontic Alumni Association.* Tax deductible checks are made out to the UWOAA and mailed directly to the Association. Credit toward "club" level is given upon receipt of the check. The donation may be directly from an alumnus or on the behalf of an alumnus by another person, such as a referring dentist. The donor receives tax credit and the alumnus receives club credit. The person contributing must indicate the name of the alumni member who should receive credit to their club level. Contact Joni Marts for "In lieu of" forms to facilitate others donating on your behalf.

2. *Contributions directed to specific funds at the UW.* Tax deductible checks are made out to the University of Washington and mailed to the Department of Orthodontics, specifying which fund the monies are to be directed (see below). The Fund Development Office then receives and processes these funds for the Department and reports their receipt to the UWOAA. The Association then gives Club credit to the UW alumni contributors. As above, another individual may donate on behalf of an alumnus directly to a specified fund and receive the tax deduction. Checks should be sent to the UW Orthodontic Department. Also, the donor should indicate which alumnus should receive credit for club status.

Redig Distinguished Service Award, named in honor of Dr. Redig who served as CDA Executive Director for 18 years, was established in 2001 to honor individuals who have provided an extraordinary contribution to the vision and goals of CDA.
