Update on the Moore-Riedel Professorship in Orthodontics

As announced March 2005, Dr. Greg King was awarded the first Moore-Riedel Professorship in Orthodontics. This award is for a five year term. Having the award go to a sitting faculty member gives great flexibility in the use of the funds. Dr King reports that two new part time faculty positions are being funded: 1) Graduate Clinic Director and 2) faculty to revise and direct the wires course. Also, Dr. King has begun the establishment of a practice-based research network of orthodontists designed to identify questions of significance to practicing orthodontists and to facilitate conducting of high quality research in private practices. The UW Dental School has been awarded \$22 million through NIH to establish the infrastructure of a practice-based research network for general dentists and he intends to leverage much of that in establishing a network of practicing orthodontists. This new concept for conducting clinically relevant research combines the strengths of practicing orthodontists with the expertise of university-based clinical researchers. He feels certain that both Dr. Moore and Dr. Riedel would approve of these endowment funds being used to focus on research aimed at solving the problems of practicing orthodontists. The initial funding for this endowment was \$250,000 from your Orthodontic Alumni Association which was matched by a grant from the State of Washington. These funds and your generous donations to this endowment are managed by the UW Consolidated Endowment Fund. The earnings of the endowment fund the Moore-Riedel Professorship.

Research funds from outside sources have become less available in recent years making our role in funding these projects even more critical.

The 26th Alton Moore Lectureship and Thesis Day was presented Friday, November 17, 2006 at the Bell Harbor International Conference Center on the Seattle waterfront. Our five new graduates presented their research during the morning session. Each did a great job. We can all be proud of the quality of the research and of our new fellow alumni. Dr. Birte Melsen of Aarhus, Denmark spoke on "Temporary Anchorage Devices for Orthodontics" during the afternoon session. The new graduates and Dr. Melsen were each presented their with a bronze replica of the famous Dr. Riedel arch-forming thumb, which were produced for the 2000 reunion by noted sculptor (and UW Orthodontic graduate) Dr. Donald Gardner.

Thesis Day 2007 will have a new format. The students will present their research on **Thursday afternoon, November 1**. The Washington Dental Service Foundation Distinguished Professorship presentation will follow on Friday and Saturday, November 2-3, 2007. UW Orthodontic Department Chairman, Dr. Greg King has been honored with this award. He has put together a first-rate 2 day program covering a wide range of topics in orthodontics. The WDSF program is designed to provide greater understanding of various specialty areas in dentistry for general dentists. This program should be very worthwhile for orthodontists, as well, and help us communicate even better with our general dental colleagues.

Message from UW Acting Department Chair Anne-Marie Bollen

While Greg King is on sabbatical, my position as Acting Chair has provided me with the opportunity to get to know and work closely with the Alumni Board. This interaction has given me a great appreciation of what the Board and the Alumni at large are doing for our Department.

I have always been aware that the Alumni help fund the resident's research projects, but I never knew to what extent. As faculty we are always striving to have our residents pursue the highest quality of research possible. However, with rising costs, this is not always an easy task. We give our residents the freedom to choose a project of their interest. Given their extensive curiosity and wide range of interests, we usually are presented with some very interesting research proposals. As a faculty it is a pleasure to help shape these research ideas. However, the financial reality unfortunately needs to be taken into consideration when designing the project. We have often used ongoing faculty grant support as a means of helping fund the resident's projects. However, with dwindling NIH funding, this is not always easy. Luckily the Alumni Association has been there to help fill in the gap. On a yearly basis, you have given financial support to most, if not all, resident research projects. This has allowed the execution of projects of very high quality. The majority of the Master's theses are eventually published in peer reviewed journals. One of these, Steve Noxon's, won the Milo Hellman award in 1999. I have included a list of publications that report on research projects done by our residents during the past 10 years. Each of these studies was at least partially supported by Alumni Association Funding.

In addition to research support, the Alumni Association financially underwrites several other departmental activities. This includes financial support for the residents to attend courses such as the Tweed course, or take the ABO written examination. There are senior luncheons, and last but not least, the Association puts on Graduation Day, which is a great way to welcome our new Alumni. On behalf of the faculty of the Department and the Residents I would like to thank the Alumni Board and the Alumni for their ongoing financial support.

Endowment Fund Report 2006

The Moore-Riedel Endowed Chair in Orthodontics was established in 1999 with the purpose of attracting and retaining distinguished faculty in the specialty of orthodontics and craniofacial biology. The board is delighted to report that this endowment has now met its pledged funding goals. In June of 2006, the Moore and Riedel fund had a balance of \$1,611,431. During fiscal year 2006, there was \$67,920 distributed toward orthodontic education. This has been a satisfying achievement by our members. The alumni board and orthodontic department extends a sincere thank you to all who funded and continue to meet your pledge toward this professorship.

The Kokich/Shapiro Endowed Fund was established in 1996 to benefit the department of Orthodontics. The purpose of this fund is to enhance the education of the graduate students in the Department of Orthodontics by bringing distinguished visiting scholars in the field of orthodontics and related subjects to the University. This fund has also met its current pledge goals. In June of 2006, the Market value of this fund was \$322,785.

During this fiscal year, \$13,688 has been distributed to meet the established purpose. Again, we thank you for your pledges and support to this fund.

Of note to our members, both of these worthy endowments are managed by the University of Washington Fund Development office, with an associated 1% annual administrative fee. Our current fund raising effort is targeted to benefit the Orthodontic Clinic Fund. After much deliberation, the board has made a choice to direct all future funding directly to the University of Washington Orthodontic Alumni Board (UWOAA). This will enable us to seek matching funds from the State of Washington or the UW and give us more input into the design and timing of the renovation. Our control of the funds will allow us to move independently, not when the University is able to undertake a full dental school remodel. Currently the pledge total for the Clinic Fund is closing on one million dollars, two-thirds on the way to our \$1.5 million goal. Alumni who have contributed to the Moore/Riedel Professorship and/or the Kokich/Shapiro Endowed Fund are likely to continue to be contacted by the University for fund raising solicitation beyond your already fulfilled pledges. Please be aware that University fund raising is distinct from our Clinic Fund even if the intended benefactor is the orthodontic department! CONTRIBUTIONS UPDATE

Your continuous and generous contributions have been the foundation for Association support to the UW Orthodontic Department. Alumni have asked about how their contributions are received and credited by the Association. Here is a brief breakdown:

TYPES OF CONTRIBUTIONS

1. *Contributions to the UW Orthodontic Alumni Association.* Tax deductible checks are made out to the UWOAA and mailed directly to the Association. Credit toward "club" level is given upon receipt of the check. The donation may be directly from an alumnus or on the behalf of an alumnus by another person, such as a referring dentist. The donor receives tax credit and the alumnus receives club credit. The person contributing must indicate the name of the alumni member who should receive credit to their club level. Contact Joni Marts for "In lieu of" forms to facilitate others donating on your behalf.

2. *Contributions directed to specific funds at the UW.* Tax deductible checks are made out to the University of Washington and mailed to the Department of Orthodontics, specifying which fund the monies are to be directed (see below). The Fund Development Office then receives and processes these funds for the Department and reports their receipt to the UWOAA. The Association then gives Club credit to the UW alumni contributors. As above, another individual may donate on behalf of an alumnus directly to a specified fund and receive the tax deduction. Checks should be sent to the UW Orthodontic Department. Also, the donor should indicate which alumnus should receive credit for club status.

Is someone donating on your behalf?

It's important that we know that so you can receive proper club credit and kudos along the way! Please encourage anyone you know who might be indicating a generous gesture on your behalf to mention your name to us.

UPDATE FOR CANADIAN DONORS

A HUSKY Family For Sure!!

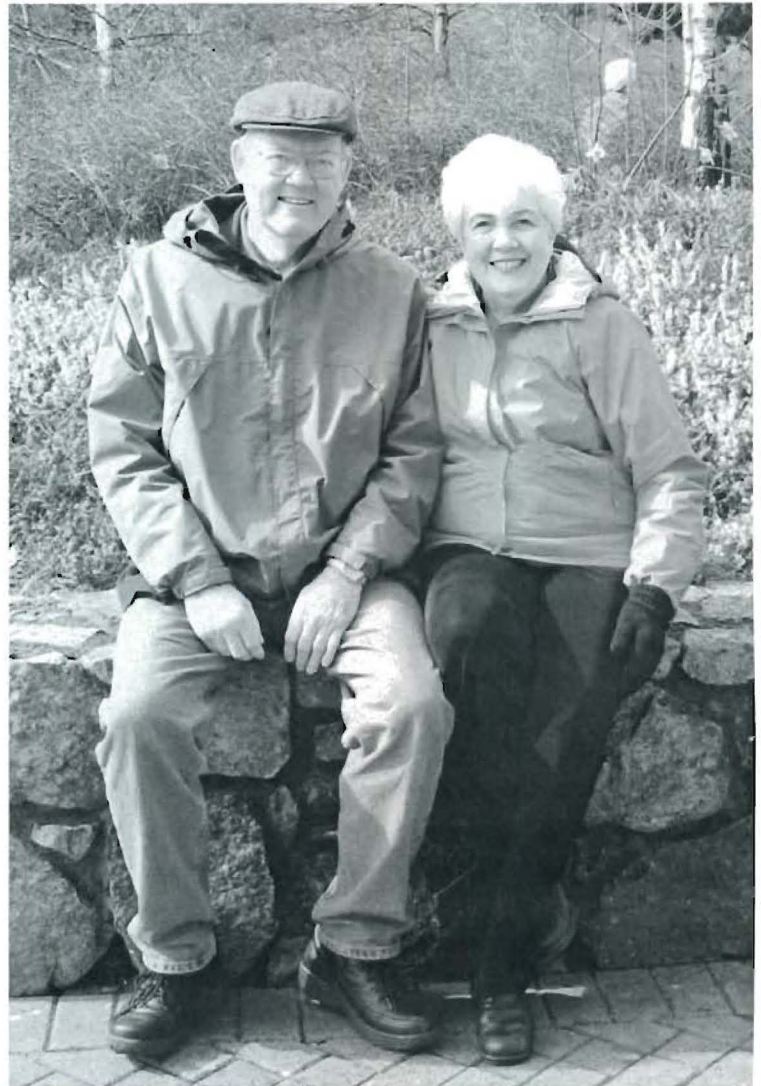
