Message from UW Department Chair Greg Huang

Greetings, UW Alums,

First, let me say that it is a privilege and an honor to be selected as the 6th Chairman of our Department of Orthodontics. We have a great program, and I would like to thank all of you for being part of our tradition. As a UW graduate myself, I know personally how deep your pride runs, as well as how high your expectations are, for our Department.

Over the years, I have come to appreciate my UW training more and more. I remember arriving in Seattle more than 20 years ago as an orthodontic graduate student, with no plans other than to return to Florida and open a practice. Immediately, I was impressed with the collegial atmosphere and the passion for orthodontics that was displayed by our faculty members. Their enthusiasm was contagious, and before we knew it, my classmates and I were all infected too. Greg King was our 5th chair, and he has guided our Department to unprecedented success in orthodontic research. Greg continues to devote significant time to new research proposals, and recently, he was named the first Moore-Riedel Professor. As such, he has established a network of orthodontists to conduct clinical research. Greg has also been a great mentor to junior faculty, including me, and we thank him for his service to the Department for the past 12 years.



CLINIC REMODEL UPDATE

Thanks again to all that have supported the Clinic Fund. I'd like to give you a brief update on our progress. The Alumni board established the Clinic Fund Committee which I chair. Our other members are Sam Lake (1981), Mike Fey (1978), Department Chair Greg Huang (1989 - replacing Greg King's committee position), Somchai Suwiwattanakul (UW architect), his assistant Lauren Eck, and Liz Follmer of the dental school. We are coming up with a pre-design plan that will lay out the basic concept, foot print and budget. Our most recent meeting focused on specifying the functions and systems needed for each area of the clinic. Much of the design comes down to thinking how the faculty will teach the grad students and to deciding what tools they will need. I can't begin to tell you how invaluable Sam and Mike are to the project. They are very busy with their families, their practices, teaching; and yet, they are giving up more of their free time making outstanding, well thought out contributions to the project. Greg Huang has jumped right in to fill Greg King's spot, and the onus is on him to visualize where he wants to lead the department.

Our total pledges are well over \$1 million, with not quite half of it collected. Our bond portfolio has suffered along with everyone else's. We will lose some principal on Lehman Brothers bonds that are in default. The good news is that we were not holding any stocks, and while we show some paper losses on some bonds, the portfolio is still entirely investment grade. There is no reason to think our portfolio will be redeemed at anything less than face value. As bonds mature, we are currently keeping the proceeds in cash, waiting for the markets to steady.

Fund raising continues despite the harrowing news from Wall Street. With the economy slowing, the Dean of the Dental School is circling the wagons – I just received notice that the annual Dean's Holiday Party has been cancelled. Obviously this may impact our clinic time table without help from the UW. This underscores the need for us to continue to fulfill and even increase our pledges.

If you are personally feeling pinched by the economic situation and need to temporarily suspend your pledge fulfillment, please let me know. We can get caught up later when things quiet down. Fortunately, so far, only one alumni has suspended their pledge, but he reaffirmed his commitment to make good on it.

One of the best ways to meet and even exceed your pledge is to ask for donations from friends and colleagues that you treat at no charge as a courtesy.

Their tax deductible donation is not in lieu of a fee, but an avenue for them to show their appreciation for your amazing UW smile creating talents.

The Alumni Board is looking forward to completing this exciting project. We have a great design team and fantastic, dedicated alumni. Look for preliminary plans to be unveiled in Kona at the Alumni Reunion!

Contribution\$ Update...

CONTRIBUTIONS UPDATE

Your continuous and generous contributions have been the foundation for Association support to the UW Orthodontic Department. Alumni have asked about how their contributions are received and credited by the Association. Here is a brief breakdown:

TYPES OF CONTRIBUTIONS

1. *Contributions to the UW Orthodontic Alumni Association.* Tax deductible checks are made out to the UWOAA and mailed directly to the Association. Credit toward "club" level is given upon receipt of the check. The donation may be directly from an alumnus or on the behalf of an alumnus by another person, such as a referring dentist. The donor receives tax credit and the alumnus receives club credit. The person contributing must indicate the name of the alumni member who should receive credit to their club level. Contact Joni Marts for "In lieu of" forms to facilitate others donating on your behalf.

2. *Contributions directed to specific funds at the UW.* Tax deductible checks are made out to the University of Washington and mailed to the Department of Orthodontics, specifying which fund the monies are to be directed (see below). The Fund Development Office then receives and processes these funds for the Department and reports their receipt to the UWOAA. The Association then gives Club credit to the UW alumni contributors. As above, another individual may donate on behalf of an alumnus directly to a specified fund and receive the tax deduction. Checks should be sent to the UW Orthodontic Department. Also, the donor should indicate which alumnus should receive credit for club status.

Is someone donating on your behalf?

It's important that we know that so you can receive proper club credit and kudos along the way! Please encourage anyone you know who might be indicating a generous gesture on your behalf to mention your name to us.

CANADIAN DONORS

There has been a question raised of whether donations to the Clinic Fund are eligible for tax deduction in Canada. 



Dr. Benjamin C. Moffett Jr.

Emeritus professor Benjamin C. Moffett Jr. from the Department of Orthodontics at University of Washington died peacefully October 1, 2008 after a long illness. Ben was born in Spring Lake, NJ, October 28, 1923 to Benjamin Moffett Sr. and Emma Jane Dodge of Bradley Beach, NJ. He attended Asbury Park High School in Neptune, NJ, and Monmouth College in West Long Branch, NJ. He volunteered in WWII (ETO) in Signal Corps. He received a BA in Zoology from Syracuse University on GI Bill, and a PhD in Anatomy from NYU.

Ben joined the Dental faculty at University of Alabama in Birmingham and later AFIP and Wayne State University. Professor Alton Moore hired him to be the biological scientist at the Orthodontic department at University of Washington, and Ben became full Professor in 1967. On his sabbaticals he returned to Europe staying in Sweden, Holland, Norway, and Finland.




Ben was an inspiring teacher and researcher who wanted to make his students think - like Socrates, whose "pupils ended up not with a firm answer, but with a much better grasp of the problem than you had before." Ben had a way with words, an inquisitive, pioneering mind, and a burning desire to improve the state of the art of clinical dentistry, especially the diagnosis and treatment of temporomandibular joint problems and to combine arts and sciences. He initiated the orthodontic wire sculpture competition. He held university and community administrative positions. Ben received numerous awards, such as Special recognition award from the American Board of Orthodontics 1986, and an award from the UW Department of Orthodontics. Ben gave the Sheldon Friel Memorial lecture at the EOS in 1981.

Like a renaissance man Ben had many interests. He was an early windsurfer, sailor, mountain climber, hiker, biker, long distance cross-country skier, ultra-light Kasper Wing flier, fisherman, folk dancer, home museum builder, photographer, music-slide show creator, historical art lover, watercolor painter, and during his last years a student of master Haida carver Ralph Bennett.

Ben is survived by his Finnish wife Leena Koskinen-Moffett, a former UW Orthodontic faculty member, younger brothers Charles (Shirley) and George, his children Joanne Taft (Earnie), David Moffett (J'ama), Anna Moffett, and grandchildren Rachel Taft and Nathan Moffett. Ben's ashes are committed to the Tahoma National Cemetery in Kent with Military Funeral Honors ceremony. FACULTY PROFILE: Dr. Allan Van Ness ('72)



Not many people can say they chose their careers at the age of five – but Allan Van Ness can! Perhaps his supportive father knew a dentist was brewing in young Allan when he was given a tour of family dentist's clinic and lab to see "how things worked." It was there that Allan realized his calling. And we're all grateful for it!

Allan was born in New Jersey, and spent his early years in Washington, D.C., where his father worked providing dictation equipment to military hospitals. In 1947, the family moved to Seattle where his father became the regional sales and service manager for Dictaphone Corp.

With his early interest in creative endeavors, Allan enjoyed working with his hands, model cars and planes. And in those days, we're not talking plastic! He happily carved, shaped and painted the models, worked with a variety of arts and crafts, perhaps displaying another sign of things to come career-wise. Allan graduated from Roosevelt High School in 1958, where he had added music to his accomplishments in the form of playing trumpet in the Rough Rider marching band. He took his perpetual interest in science to the UW, where he graduated with a degree in Zoology.

In 1962-66, Allan attended the UW Dental School, and then joined the Navy, first serving a rotating internship in Oakland at the Oak Knoll Naval Hospital. He was then transferred to Japan, where he enjoyed several years serving in a Navy dependents' clinic. Allan found his Navy career professionally stimulating and the time in Japan enjoyable. A conversation with fellow Navy Intern and UW alum John Grubb ('71) during a week's leave in Seattle set the stage for Allan's next career move. He applied and was accepted into the UW Ortho program, becoming one of eleven students slated to graduate in 1972.

Allan thrived under the tutelage of Alton Moore, Department Chair Dick Riedel, Don Joondeph ('71), Bill McNeill ('64), Ben Moffett and numerous part time clinical instructors. Half way through his ortho studies, Allan was approached by Dr. Moore about accepting an available fellowship in research and teaching. This in turn propelled Allan to simultaneously complete his degree and teach, and to realize his love of scientific academia assisting ortho students with their research in the Primate Center. Allan continued half-time on the faculty for the next 10 years, teaching both undergraduate dental students and periodontic, prosthodontic and orthodontic graduate students. At the same time, he set up practices in Bothell and Monroe. Fellow UW alum Mike Fey ('78) joined the Bothell practice and they worked together until 1998, when Mike's daughter, Krissy Grey ('98) joined the practice. Allan then returned to his "old office" in Bothell and continued in Monroe.

Allan has shared his expertise in many arenas. He served as Presidents of the Northshore Rotary Club and Washington State Society of Orthodontists and was on the Board of the University of Washington Orthodontic Alumni Association, where he was responsible obtaining the Association's 501 C3 status in the late 1970's. In 2005, he expanded his leadership expertise as he began a political career as Council Member in the City of Kenmore.

Allan retired from active orthodontic practice in June, 2008. Having spent years focusing on his practice, he is excited to be working with the orthodontic students on a weekly basis. He is teaching in the Thursday morning clinic and seminar, as well as the occlusion course with the Prosthodontics Dept and an upcoming biomechanics review class for the 2nd year students in preparation for the Boards.

Outside of his dental work, Allan still enjoys putting things together. He has taken that talent home, literally, where he works on construction projects and remodeling. His hobbies of digital photography and wood working, family and church activities fill his free time. After years of owning sailboats and sailing in the Northwest, Allan has brought his love of sailing to a new dimension as he enjoys working with radio-controlled sailboats.


As far as future travel plans go, Allan and wife Barbara are hoping to get to Europe. They also look forward to serving a senior mission for the LDS church.

Jacob DaBell provided a winder ice skating scene, complete with a "stumbler" in the snow!




Tom Houlihan brings love of his homeland in his beautifully crafted shamrock and harp!
