MESSAGE FROM THE CHAIRMAN -*Peter Shapiro*-

The heart of our program is the faculty and staff, and I would like to tell you a little bit about them. The full-time faculty members are **Jon Artun, Anne-Marie Bollen, Sue Herring, Doug Ramsay** and me. Jon received his dental and orthodontic education at the University of Oslo. He spent the 1984-85 academic year here as a visiting Professor and then returned on a permanent basis in 1988. As you know from the literature, he has been a very productive clinical researcher. Anne-Marie received her dental education in Belgium and her orthodontic education and Ph.D. from the University of Michigan. Most of her time is spent conducting research sponsored by NIH in the area of bone metabolism. Doug is a product of the UW dentist-scientist program in which he received a Ph.D. in psychology and his orthodontic training. Doug is a very energetic teacher/researcher who is appointed half-time in our Department and half-time in the Department of Pediatric Dentistry. Sue earned her Ph.D. in anatomy from the University of Chicago and from 1972 to 1989 taught at the University of Illinois College of Dentistry. Sue is responsible for the course in Orofacial Biology and is an outstanding researcher in the area of functional morphology.

Our halftime faculty members are **Don Joondeph, Vince Kokich** and **Bob Little**. As you know, Don just completed his term as President of the American Board of Orthodontics. Vince coordinates our research program and recently was appointed as a director of the ABO. Bob coordinates our graduate program and has been in charge of our long-term postretention sample. The sample has increased steadily in the last few years as each student is required to gather the records of two ten- and one twenty-year postretention patients.

The clinical faculty are as follows: Monday - **Don Joondeph, Dave Turpin** and **Dave Crouch**; Tuesday (orthognathic surgical clinic) - **Terry Wallen, Don Joondeph** and **Brett Fidler**; Wednesday morning - **Vince Kokich, Tim Quinn, Dick Jones, Ward Smalley** and me; Wednesday afternoon (adult perio/ restorative/ortho clinic) - **Jon Artun, John Moore** and **John Ive**; Thursday - **Bob Little, Jon Artun, Ray Kubisch, and Diane Doppel**; and Friday - **Stan Hall** and **Roy Gunsolus** and **Dick Releford**. Another group of faculty teach part-time in various capacities: **Dick Riedel, Ben Moffett, Leena-Koskinen-Moffett, Al Van Ness, David Weed, Lena Omnell, Barbara Sheller, Bryan Williams** and **Jim Howard**. This is an outstanding and dedicated group of faculty, most of whom volunteer their time.

The support staff also is a wonderful group of people, a number of whom has worked in the Department for many years. The administrative office is staffed by **Kathie Long** and **Barbara Richards**. Barbara "retired" a year ago, but comes in regularly to help out. **Jim Clark** is our long-time photographer who doubles as our computer handyman. In the clinic **Peg Evered** is the receptionist, **Dorothy Scholz** handles the billing and **John Fagerholm** assists faculty and students. As former students, you know how important these people are in running the program.

Our graduate students are the finest. They are typically selected from an applicant pool of about 200. They are a joy to teach and clearly one of the major reasons we attract such superb faculty.

If it sounds as if I am bragging about the people in our Department, I am. Our physical facility is excellent and the University of Washington is a terrific institution, but it is the people that make this a really great Department. As alumni you should be proud of them and confident in their abilities to provide a first-class educational experience.

Lastly, I would like to thank the alumni for all of your support, both moral and financial. In particular I would like to acknowledge the efforts of your Board of Directors who take their responsibilities very seriously. Without your help, we would struggle to maintain a viable research program and provide so many things that enrich our Department.

It was heartening to hear that over 65 alumni have joined the Century Club (\$1000+ donations) since our Reunion in 1988. We are now nearing the goal of raising an endowment of \$500,000 whereby the interest will nearly subsidize the research activity of the Department. We are grateful for your continuous giving and generosity.

Our Department has been a perennial leader in teaching and research since its inception. As **Peter Shapiro** highlighted at the Reunion, the alumni Board has enthusiastically endorsed the establishment of an "Endowed Chair" for a visiting professor to join our faculty for up to one year depending on the endowment available. Generally it requires a million dollar endowment to host a professor for one year. The one year "Endowed Chair" will provide many unique educational opportunities for the students, faculty and alumni. This dream could be a reality in the next four years with your continued financial support.

The alumni Board has made a decision for graduated annual dues for newly graduated students because of generally slow practice starts as well as optional dues for fully retired alumni who have been the financial backbone to the Association. We still depend on the retired alumni for support. More details will be highlighted in this newsletter.

Mark your calendars! The next University of Washington Update is scheduled for March 18-25, 1995, in the beautiful resort area of Ixtapa/Zihuatanejo on the West coast of Mexico. Prepare for a wonderful vacation-education fun filled week. We'll keep you posted.

Randy Inouye (83) is associating with **Dr. Harry Hatasaka (60)** in Palo Alto, CA.

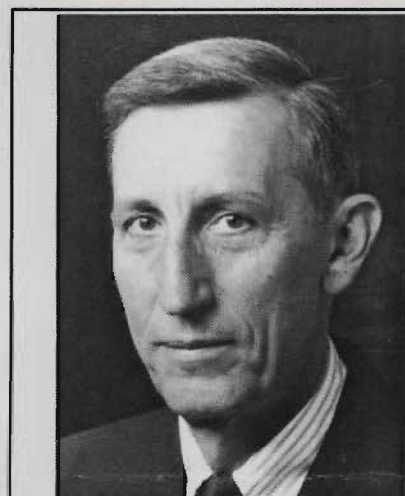
Alan Irvin (84), his wife Laura and son Christopher enjoyed our Reunion and spending time in "beautiful Seattle!"
