*The Laser Doppler Flowmeter (r)* provides a non-invasive method for measuring blood flow.



*Differential Variable Reluctance Transducer - AKA - "The Gadget" (l)* is a small, implantable device that measures minute distortions of tissue. It was developed for use in the ligaments of the human knee. The Department is using it to examine distortions of the IMS disc during function in pigs.



## Faculty Profile

### DIANE DOPPEL - Class of 1990

Teaching at the UW has, in a sense, led Diane full circle from her initial career goal of being a teacher.

She was born in Oakland, MD in 1964. Her home town was so small that they didn't have an orthodontist - so - Diane's mom drove her 50 miles for her regular orthodontic appointments. Diane graduated from high school at age 16 and went to Cedarville College, a small private college in Ohio, majoring in secondary education with emphasis on science and music. Although Diane had studied music since the age of 5 (cornet and flute!), she decided to major in Biology. Home for a retainer check, Diane was asked by her orthodontist what she intended to do with her Biology degree. Diane's response was "Oh, I'll probably end up being the head bottle washer in a lab somewhere!" Her orthodontist, Dr. Curtis Freidenberg, saw the potential and suggested that Diane consider dentistry. Diane had already had the opportunity to observe in Dr. Freidenberg's office and knew that he enjoyed what he did. It all seemed to fit - so - after graduation, Diane attended the University of Maryland Baltimore Dental School. She went on to graduate from the University of Washington Orthodontics Department in 1990 and purchased a practice from Dr. Kenneth Kahn ('50).

Diane met her husband, Geoffrey Perr, DDS, through her orthodontic classmate, Tom Popp. Tom and Geoff had gone through dental school together and Tom introduced the two about a month after Diane moved here. They were married in 1991. Diane and Geoff enjoy water skiing, snow skiing, and an occasional game of tennis. They moved into their home on Mercer Island in April, and have enjoyed working to make it special. Diane finds being with the high calibre students at the UW challenging, stimulating and a great learning experience for herself.

Diane serves on the Board of Directors for the WA State Society of Orthodontists as well as the UW Orthodontic Alumni Association.

### DOUGLAS RAMSAY - Class of 1990

Doug joined the faculty in 1990 following completion of his graduate training in Orthodontics at the UW. He attended the University of Pennsylvania School of Dental Medicine from 1979-1983 and upon graduation moved to Seattle to pursue a career in academics. Initially, Doug was supported by a federally-funded training grant from the National Institute of Dental Research (NIDR) to conduct behaviorally oriented dental research while pursuing a PhD in psychology. Then, in 1985, Doug became the first person to enter the University of Washington's newly awarded Dentist-Scientist Program. This NIDR-sponsored program provided Doug the necessary support to complete his doctorate in psychology (1988) as well as his orthodontic specialty training.

Doug teaches at both the undergraduate and graduate levels in our Department and he holds a joint appointment in the Department of Pediatric Dentistry. He practices orthodontics one day a week within the School of Dentistry. Doug also directs an active federally funded research program. One of his several research interests pertains to the vascular consequences of orthodontics and orthognathic surgical procedures. Using a laser Doppler flowmeter (which was purchased with partial support from our Alumni Association), Doug and our graduate students have investigated blood flow changes that occur in association with orthodontic forces and orthognathic surgical procedures.

Doug recently married Michelle Brot (see the photo in our Let's Catch Up section) just two weeks prior to the tenth anniversary of their first meeting. Michelle is completing a postdoctoral fellowship in the Department of Neuropharmacology at the Scripps Research Institute in La Jolla, California. She will be returning to Seattle this December to continue her research at the University of Washington. One of Doug's favorite pastimes is trying to keep up with Michelle!



## *My Friend Dick Riedel*

On August 10, 1994 Orthodontics lost a leader in orthodontic education and practice. He introduced through his master's thesis one of the most widely accepted diagnostic cephalometric measurements in use today - the difference between angles SNA and SNB or the ANB angles.

His advocacy and insistence on gathering complete long-range orthodontic records for every patient continuing over spans of 30 to 40 years plus, has left a research legacy available for study for years to come. His studies of long-range orthodontic treatment stability have spearheaded much of the research in this area.

These two specific examples of his many contributions to orthodontic education and research are overshadowed by his skills as a teacher and clinician and are only surpassed by his personal values, integrity, and ethics. Those of us who were fortunate enough to be close to him, loved him and will miss him greatly. Fortunately for us and orthodontics he has inculcated his spirit and values in many of his students and colleagues over the years. He has left the world and dental programs better off for his being among us.

Dick was born February 26, 1922 in Milwaukee, Wisconsin. He was a World War II veteran of the U.S. Navy Dental Corps and served with a Marine battalion in China for two years. He was a graduate of the Marquette University School of Dentistry and Northwestern University Graduate School in Orthodontics. After a brief period of time on Northwestern's faculty, he moved to Seattle in 1949 to join the faculty of the then-new dental school of the University of Washington. Over the next few years he rose in academic rank from Instructor to Professor and served as Chairman of the Department of Orthodontics from 1966-75. He served as Associate Dean for several years and became Acting Dean of the School of Dentistry in 1980-81. Upon retirement he was appointed Professor Emeritus of Orthodontics in 1983, however, he continued to actively participate in the Department's teaching and research program until shortly before he died.

He practiced orthodontics part-time briefly in Chicago with John R. Thompson before joining the Washington faculty. In 1950 he established his own private practice in Seattle which he maintained until his retirement in 1983. I joined him in the office on a part-time basis for many of those years. He was a member and leader of numerous professional societies and served as president of American Board of Orthodontics and the Northwest Component of the Angle Society of Orthodontists. He received many national honors and awards during his career, culminating in 1983 with the Albert Ketcham Award given annually by the American Board of Orthodontists. He was the author of many scientific articles in the orthodontic literature and edited and contributed chapters to several orthodontic textbooks.

He is survived by his loving wife of 49 years, Marie; a son, Richard Riedel of Seattle; two daughters, Corrine Lyon of Athens, Greece and Caryl Riedel of Denver, Colorado; and five grandchildren.

Since 1975, Dr. Proffit has served as professor and chairman of the Department of Orthodontics at the University of North Carolina Dental School. In 1992 he was named Kenan Professor. He has published nearly 100 scientific papers and is the author of "Contemporary Orthodontics," the most widely used text in the field. Dr. Proffit is a diplomate of the American Board of Orthodontics and presents about 15 continuing education courses annually in the United States and abroad.

**Eugene Supernaw ('55)** was pleased to present a post-graduate lecture at the Saint Louis Medical Center in conjunction with the annual meeting of the Orthodontic Education and Research Foundation in March of 1993. Dr. Supernaw said the experience was particularly gratifying as he participated with other UW graduates and faculty.
