Message to the Alumni

The Alumni Newsletter will be published once annually, in November, by the University of Washington Orthodontic Alumni Association. Publication of the Newsletter has two purposes: first, to provide alumni with news about the Orthodontic Department and its students, faculty members and alumni; and second, to remind alumni that now is the time to make their annual contributions to the University of Washington Orthodontic Memorial Fund.

Solicitation of funds is always difficult, but the task is made easier with the knowledge that the need is great and that the funds are well spent. Since its inception, the Memorial Fund has been used to support the research and publication activities of the students and faculty. These activities have played significant roles in establishing and maintaining our orthodontic program as one of the finest in the world. Financial support for the departmental research and publication activities is derived primarily from the Memorial Fund and from grants from the federal government. Due to general belt-tightening by the federal government (at least in the area of research support!), it has become increasingly difficult to maintain a continuous level of support for our research. The importance of the Memorial Fund has increased, therefore, since it will have to be relied upon to weather sporadic funding crises. Unfortunately, contributions to the Memorial Fund have been decreasing for the past several years.

We, therefore, appeal to all alumni to contribute at least \$100 to the Memorial Fund (an envelope is attached to the Newsletter for this purpose) and to make this contribution an annual practice. With your help we will be better able to insure that adequate financial support will be available to the Department to continue its outstanding educational and research programs.

Dr. Moore Observes 30th Year at UW

Special congratulations are due Dr. Alton W. Moore, who is celebrating his 30th year of association with the University of Washington School of Dentistry. Dr. Moore founded the Department of Orthodontics in 1948 and was its first chairman, serving until 1965. At that time he assumed the responsibility of associate dean in the School of Dentistry while continuing to teach and chair research projects in the department. In August 1977, after returning from a year's sabbatical leave in Nijmegen, The Netherlands, Dr. Moore assumed the post of dean of the School of Dentistry. Under his fine leadership, the School of Dentistry is maintaining its international reputation for excellence. Although Dr. Moore's time is currently at a premium he still manages to maintain contact with the graduate orthodontic program.

The University of Washington Orthodontic Alumni Association's fifth reunion meeting will be held in Seattle at the Washington Plaza on July 29-August 2, 1979. Plan now to attend what promises to be a memorable event. Graduate Curriculum Expanded

The graduate curriculum has been modified to meet the changing demands of dentistry. In recent years, greater emphasis has been placed on developing interdisciplinary patient care programs with related dental fields. This team approach enables us to deliver a much higher level of total patient care, giving the orthodontic specialist greater insight into the problems beyond his own area of expertise as well as enabling him to coordinate the treatment of patients presenting with complex orofacial problems.

The clinical program consists of four half-day seminar and clinic sessions in which the graduate orthodontic students treat the "traditional" orthodontic patient. This group includes patients in the mixed or permanent dentition that require full orthodontic therapy. Emphasis is placed on the diagnosing and timing of treatment based upon individual needs and growth patterns.

Additionally, the curriculum has expanded to include a half-day surgical-orthodontic clinic where graduate orthodontic students are able to treat adult patients with limitations due to severity and/or lack of growth and younger individuals presenting with severe skeletal dysplasias or craniofacial anomalies. Another half-day seminar and clinic session is devoted to the treatment of patients requiring conjoint orthodontic, periodontic and restorative therapy. Emphasis is placed on collaborating with other specialists in the diagnosis and treatment planning of patients with these complex dental problems.

Finally, the department has initiated a clinic for patients presenting with temporo-

mandibular joint dysfunction. Faculty from various fields form teams to diagnose, treat and maintain long term patient records to more fully understand the nature of temporo-mandibular joint disease. The graduate orthodontic students participate in this seminar and clinic and are assigned patients with specific joint disorders.

In summary, the department is continuing to emphasize quality orthodontic care for patients with mixed and permanent dentition while preparing the student to be able to coordinate a team approach to patient care for individuals with complex oral facial problems.

Alumnus Named Dean at UOP

Dr. Arthur A. Dugoni, a 1963 graduate of the UW postdoctoral orthodontic program and a member of the Board of Directors of the UW Orthodontic Alumni Association, has been named dean of the School of Dentistry of the University of the Pacific (UOP), San Francisco.

Dr. Dugoni, a San Francisco practitioner, has been a member of the school's faculty for 24 years. He is a 1948 graduate of the San Francisco school, which at that time was the College of Physicians and Surgeons.

He has taught in the UOP Department of Orthodontics for 15 years and was chairman of the department in 1964-1965. He is presently an adjunct professor in the school's postdoctoral orthodontic program.

Dr. Dugoni is a diplomate of the American Board of Orthodontics, a deputy regent of the International College of Dentists and a ten-year member of the House of Delegates of the American Dental Association.

He is a vice president of California Dental Service and a past president of the Northern California Section of the American College of Dentists, the Central Section of the Pacific Coast Society of Orthodontists, and the San Mateo County Dental Society. He was named South San Francisco's 1960 "Person of the Year."
