Program

The Alumni Program Committee has been assembling clinics and speakers for the second University of Washington Orthodontic Alumni Reunion this summer. Although the program is not at this time completely formalized, it might be of value in planning your trip to be informed as to the dates and times of the scientific part of the program.

We plan on utilizing Sunday afternoon, August 8, starting about 3:30, for the dedication of the Founders Room. This will be followed by a cocktail party and dinner at the Windjammer restaurant.

Monday morning, August 9, will be for registration, a welcoming address, and a lecture clinic on clinical and record photography. On Monday afternoon, following our customary business luncheon, we will view and discuss cases and appliances currently used in treatment at the Orthodontic Clinic. A round table discussion on appliances and treatment will complete Monday's activities.

On Tuesday morning, we will have two papers presented and complete the day's program with the first half of the table clinic presentations. Tuesday afternoon is open for social activities and orthodontic discussions on an informal basis may be carried on at a local golf course.

Wednesday morning's program will complete the formal part of the meeting. Two papers will open the program and the final half of the table clinics will be presented prior to adjournment. The meeting will be closed at noon on Wednesday, August 11.

However, to effect a true cross sectional view of orthodontic thinking among our graduates in different areas of the country, we would certainly appreciate any suggestions or volunteers for either papers or clinics.
